## Public Defense Updates

### ***People v. Kopp***

The California Supreme Court recently issued an opinion in *People v. Kopp* (2025) ---Cal.5th --- (2025 WL 3755596), addressing the trial courts' constitutional duty to determine a defendant's inability to pay fines, fees and assessments before imposing them. For punitive fines, the Court did not find a due process requirement to hold an ability to pay hearing before imposing every punitive fine, but also held that challenges to punitive fines should initially be reviewed under the excessive fines clause. For specified ancillary costs, a trial court, upon request, is required to consider a defendant's inability to pay, and failure to do so is a violation of equal protection.

**Trial Skills Fundamentals** is a practical, skills-based course designed for defense team members seeking a cohesive framework for preparing and trying criminal cases. The course centers on developing a clear, persuasive theory of the case and carrying it consistently through jury selection, opening statement, witness examination, and closing argument. Emphasizing narrative, strategy, and credibility, the course integrates legal analysis with factual development and emotional resonance, while reinforcing ethical, client-centered advocacy.

By the end of the course, participants will have the framework to articulate a defensible and adaptable theory of the case; identify and address juror beliefs that may hinder acceptance of the defense narrative; frame evidence effectively in opening statements; examine witnesses in a manner aligned with defense theory; and synthesize facts, law, and theme into a coherent closing argument. Throughout, learners will practice skills that promote client-centered lawyering, strategic decision-making, clarity of communication, and disciplined trial preparation applicable across a wide range of criminal cases. ### **Generative AI and Prosecutorial Misconduct**

With the rapid spread of generative AI tools, more courts are encountering briefs and pleadings containing fabricated case law, misquoted authority, and unreliable analysis. While defense misuse has received significant public attention, far less scrutiny has been directed toward similar issues in prosecutorial filings. To understand the scope of the problem and respond effectively, defenders need shared awareness and a framework for recognizing filings which constitute misconduct when they appear. This webinar will help defense teams recognize what AI-generated legal writing looks like, understand how to document suspected misuse, and explore the legal tools available when fabricated or unreliable content is submitted to the court. By exchanging examples, experiences, and strategies, we can begin identifying statewide patterns and ensure client protection when the process is compromised by unverified AI.






